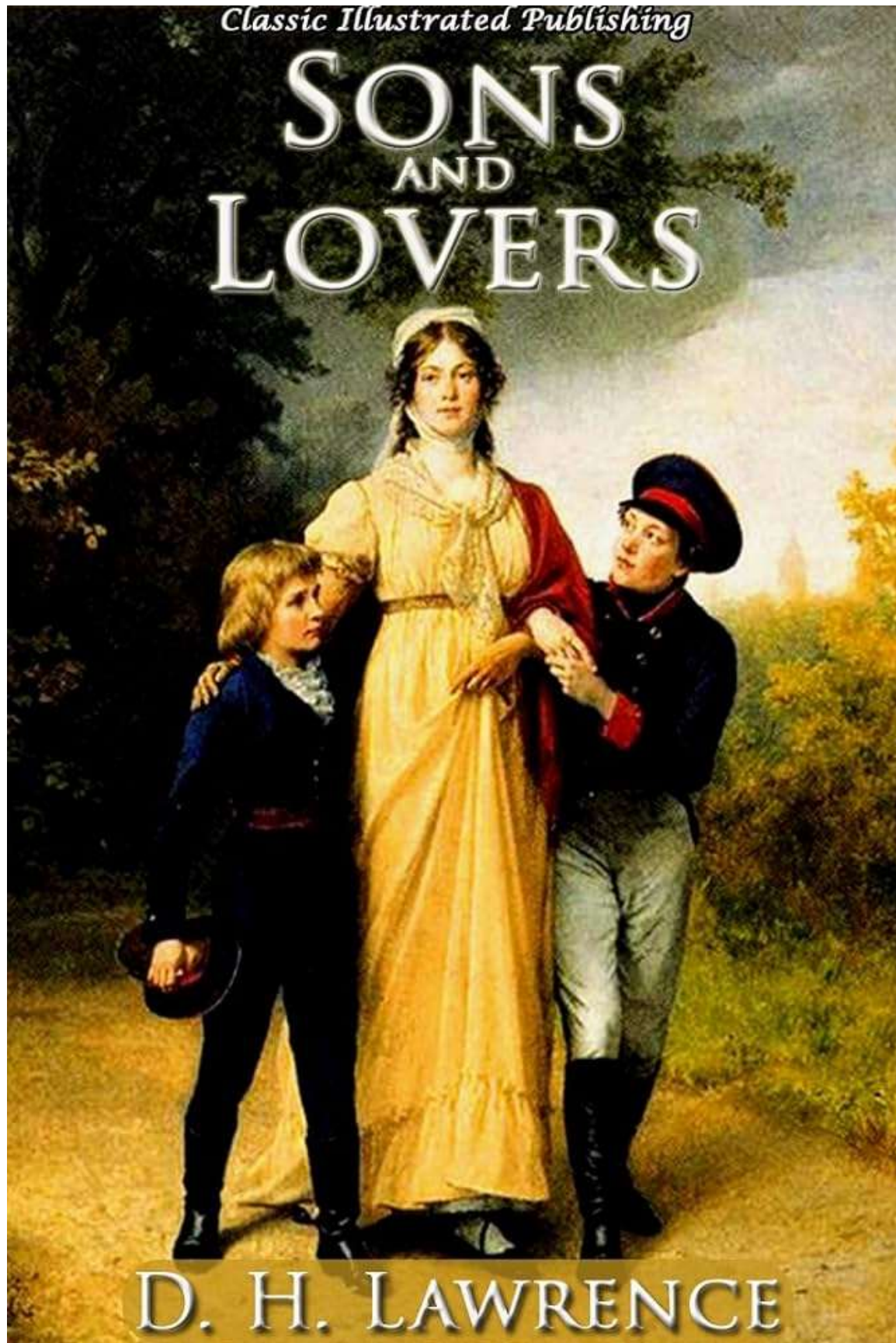
ABSTRACT
